4. Details of our assessment**CQA Validation Report: Monitoring Infrastructure**

In accordance with Condition 2.6.7 of the EPR Permit, the operator is required to submit a CQA Validation Report following the construction of any new landfill infrastructure. Landfill infrastructure is defined within Schedule 7 of the EPR Permit and includes groundwater and landfill gas monitoring boreholes.

During August 2025, the Operator installed the following monitoring infrastructure:

- 6 – Groundwater Monitoring Boreholes
- 28 – Landfill Gas Monitoring Boreholes

The groundwater monitoring boreholes included both replacement wells and new locations throughout Phase 3. These new locations were selected to provide additional groundwater level data to inform future developments.

The landfill gas monitoring boreholes were drilled to shallow depths, specifically targeting the unsaturated zone. This approach enables more representative sampling of perimeter soil gas conditions.

To discharge the requirements of Condition 2.6.7, the operator submitted the following document:

- Geotechnology Ltd report “CQA VALIDATION – NEW GROUNDWATER AND GAS MONITORING WELLS”. Report Number: 2478r2v1d0925. Date: September 2025.

NRW can confirm that it is satisfied¹ with the CQA Validation Report for the construction of the new monitoring boreholes.
