4. Details of our assessment

Resources Management (UK) Limited (RML) has submitted revised waste acceptance procedures for disposal activities at Withyhedge Landfill. These revised procedures apply exclusively to waste imported directly from Dauson Environmental Group Ltd sites – namely, Atlantic Recycling Ltd and Neal Soil Suppliers Ltd.

The document describes how RML will:

- Confirm that wastes accepted for disposal are compliant with the site's environmental permits.
- Obtain and assess the waste producer's basic characterisation.
- Confirm the waste's classification as inert or non-hazardous.
- Conduct on-site verification.
- Manage non-conforming wastes.

The revised procedures are detailed in the operator's document titled:

- "RML - Waste Acceptance (NSSL ARL Only) – v2.0". Dated: 02 September 2025.

Following a review, NRW has accepted the waste acceptance procedures outlined in the referenced document. This document will now form part of the EPR Permit, incorporated under Operating Techniques (Permit Condition 2.3.1a).

The site's waste acceptance procedures should be reviewed regularly to ensure they remain appropriate. Any proposed revision must be submitted to NRW for approval.

The following caveats apply to our decision:

- The accepted procedures are limited to activities undertaken at the permitted installations at Withyhedge Landfill (MP3330WP & QP3098FL).
 - Acceptance of these procedures does not imply that any approval is given to the activities undertaken at other installations operated by the Dauson Group.
- The accepted procedures only apply to wastes imported from Dauson Group sites.
 - A separate or revised waste acceptance procedure will be required ahead of waste acceptance from third parties.

The Operator must now ensure that all relevant staff are aware of their responsibilities under the revised procedures and that appropriate training is provided.

Legal status of this report

Your permit is issued to you under the Environmental Permitting Regulations. You have a responsibility to comply with the conditions of your permit and prevent pollution/harm of the environment.
