4. Details of our assessment**CQA Plan – Cell 9 Permanent Gas Collection Infrastructure – Record of Acceptance**

The permit (condition 2.6.5) requires the operator to submit construction proposals, prior to the construction of any landfill infrastructure. Construction should not commence until Natural Resources Wales (NRW) has confirmed that it is satisfied with the construction proposals.

The operator has submitted construction proposals for the installation of permanent gas collection infrastructure throughout Cell 9. The construction proposals consist of the following documents/submissions:

- Geotechnology Report: Withyhedge Landfill Site 2025 Gas Extraction Wells (Cell 9). Report Number: 2597r1v1d0925. Dated September 2025.

NRW can now confirm that it is satisfied with the above submissions subject to the following caveats:

- The density of the gas collection infrastructure should remain consistent with the CQA Plan unless otherwise agreed in writing with NRW.
- Once installed, gas collection infrastructure should be connected to the site's landfill gas extraction system as a matter of urgency, to maximise gas collection and minimise malodorous emissions.
- Monitoring and landfill gas management plans should be updated to reflect the changes to the gas extraction system.

Please note that the acceptance of these CQA proposals, by NRW, does not mean that the assumptions, design specifications or testing regimes will be suitable for any future development at the site.
