4. Details of our assessment

I attended site on a pre-arranged OSM inspection and was met by the Operational Supervisor and Process Scientist. The weather was heavy showers and strong gusts.

The site permit was varied in March 2025 to include a P backstop and provision for dosing, the site has not yet included Fe dosing facilities. The inlet was flowing clear with sensors and screens in place. Due to the quirks of the site the flow then dog-legs to accommodate the flow sensors before entering primary settlement. There were some signs of aging in the

tank but this is true across the site and has already been noted by the DCWW Ops staff with plans in place for repairs. The two filter beds appeared to be in good condition although there was a large amount of vegetation within the outflow channels. The distribution/siphon chamber also had some age-related issues but was also already scheduled for repair. Both filter bed arms were operating freely during the inspection. The Humus tank had some more leaves but otherwise appeared to be in good condition and the outflow/sample point was clear. The two sludge tanks also had works scheduled to repair the central wall.
