Natural Resources Wales officer Shaun Rees met with Mrs Eluned Jones - Bright to carry out a routine inspection of the site on the 20 October 2025 at 10:30.

### **1.1 General Management**

During the visit, it was noted that the air scrubbing unit were both operating with a pH of 4.2 and 4.7, air scrubber units have an appropriate limits for pH, this being below 3.5.

This was rectified post visit and photographic evidence provided.
