This meeting was to review GD's response to the Regulation 61 Notice issued earlier this year.

The BAT conclusions (BATc) document was discussed and GD were given a spreadsheet to help them with their reply to each BATc.

A full analysis of the incoming waste will be needed to justify GD's input and output testing regimes as the BATc (BAT 3 and BAT 7) require monitoring of substances that are unlikely to be present in the incoming waste, but GD need to demonstrate that this is so. Samples will be taken from the receiving tank every tank turnover for three tank turnovers. These samples should be sent for a full analysis at an accredited laboratory. The determinands are listed in BAT 7.

GD also need to write an energy efficiency plan, as described in BAT 23.

GD have been sent an electronic copy of the BATc spreadsheet.
