### 4. Details of our assessment

This site serves a 505 population equivalent. It is also classed as a low flows passed forwards (FPF) site. Advanced enabling works were completed in 2024 which consisted of demolishing of old storm tank and further ancillary works. Scheme wasn't progressed any further due to affordability. Following ongoing permitting discussions with NRW new permit conditions are coming into effect as of 2030. This scheme will be picked back up and re-released in 2025 to address the permit changes and the existing FPF increase that has come into effect. Expectation is to review existing solution and understand any amendments needed to meet new permit conditions. Future new works expected to be a rotating bio-contactors. Unsure what format.

Other comments: infiltration is present but not seen as priority. FPF compliant at time of visit but the inspector observed that it would not take much more of an increase in flows before the site spilled to storm.

EDM sensor present on spill weir - it was noted that it may need adjusting because it tends to report spills when the weir is not spilling.

The single filter bed can get overloaded, especially when sludge supernatant is set to recirculate during higher flows. Fpf permit is currently 10.4 litres per second and will remain at that level past 2030.

Majority of flow reaching the works is pumped but a small amount arrives by gravity.

No problems observed at the time of inspection.
