### Waungron Road Household Recycling Centre

The Waste Regulation Higher Education Officer Cariad Evans and the Waste Regulation Higher Education Officer Dafydd Evans went for a site inspection of the permitted site EPR/VP3999FM on the 17th of June 2025. The weather was sunny, warm, and dry. As the site status is non-operational, the purpose of the visit was to confirm there were no operations carried out at the site.

The gate was locked and secured and the site appears to remain non-operational, with no waste observed on site at the time of the visit
