4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised to review the submitted Q2 & Q3 Monitoring Returns.

Q2 Monitoring Returns

Leachate Levels

Leachate levels were compliant in quarter 2 as required by Table S3.1.

Leachate

Six monthly leachate monitoring was conducted in May 2025 as per Permit Condition 3.5.1(a), Schedule 3, Table S3.8 with all required parameters reported.

Surface Water

Monitoring of surface water was carried out as required by Tables S3.3 & S3.9.

Groundwater

Groundwater samples were taken throughout the monitoring period in accordance with Tables S3.4 and S3.10 and the results of the monitoring were submitted as required.

Zinc has been added to quarterly monitoring by the operator although the permit only requires annual monitoring of this parameter. The operator is conducting this extra monitoring to establish the trend of Zn in groundwater due to recent exceedances. Zn was compliant for this quarter.

Landfill Gas

Landfill gas in external monitoring boreholes was monitored as per the requirements of Table S3.5. Boreholes T11 is a monitoring point with constantly high CH₄ levels that are known not to be of landfill origin. T11 is in close proximity to T10 and is believed to give rise to interference of recorded gas levels at T10. During this reporting period however, CH₄ did not exceed the 1% v/v CH₄ emission limit value at T10. All other boreholes were compliant for this quarter.

Q3 Monitoring Returns**Leachate Levels**

Leachate levels were compliant in quarter 3 as by Table S3.1.

Leachate

Six monthly leachate monitoring was conducted in May 2025 as per Permit Condition 3.5.1(a), Schedule 3, Table S3.8 with all required parameters reported. The next round of 6 monthly and annual leachate quality monitoring will normally take place in November 2025.

Surface Water

Monitoring of surface water was carried out as required by Tables S3.3 & S3.9.

Groundwater

No breaches were reported for groundwater parameters.

Landfill Gas in External Monitoring

Landfill gas in external monitoring boreholes was monitored as per the requirements of Table S3.5. Boreholes T11 is a monitoring point with constantly high CH₄ levels that are known not to be of landfill origin. T11 is in close proximity to T10 and is believed to give rise to interference of recorded gas levels at T10. During this reporting period however, CH₄ did not exceed the 1% v/v CH₄ emission limit value at T10. All other boreholes were compliant for this quarter.

G3, G4, G8, G9, T1,T2, T10 had CO₂ reading above their action limits.

Action: Investigate high CO₂ reading.
