On 10 November 2025, representatives from Natural Resources Wales (NRW) and Dŵr Cymru Welsh Water (DCWW) met to discuss the Flow Pass Forward (FPF) at Ganol Sewage Treatment Works (STW).

Agreed Actions (to be undertaken by DCWW):

- 1. Provide Current FPF Flow Rate**
Submit the current FPF flow rate being achieved at Ganol STW to NRW by **1 December 2025**.
- 2. Route to Compliance Methodology**
Deliver a detailed "Route to Compliance" methodology to NRW by **31 March 2026**
- 3. Provide NRW with an up to date copy of the WOM for the Ganol STW 1 December 2025**
