3. What will happen next?

4. Details of our assessment

On the 14th October 2025, Senior Environment Officer from Cwm Taf and Bridgend Environment Team and Fisheries Officer from Cardiff and Vale Environment Team met with representatives from ABP and their consultants JBA.

In the meeting we discussed the newly prepared design statement for the ABP abstraction licence works dated June 2025. The discussions included:

- Potential new location for abstraction upstream
- Different design options for new location and existing location
- Costs and Benefits of both options
- Flow monitoring

NRW confirmed at this stage that there are no concerns with ABP investigating a potential new abstraction in the area of the location suggested by the report. More work will be required to determine suitability of location by ABP, and any change in abstraction location will require a variation to the abstraction licence.

ABP have begun discussions with Cardiff Council Parks team and will look to engage the planning team shortly. Primary discussions indicate that the parks team are more in favour of moving the intake to a new location, however this will require further discussion.

The level gauge in the feeder channel has been in place now for 3 months and is producing a range of gauged flows for use in future control system. ABP will be looking at creating an automated system to control the abstraction in accordance with the licence.

NRW advised that works will require a FRAP, and a new intake location will require a geomorphology and WFD assessment to be submitted with any application to vary the abstraction licence, and for the FRAP.

Action

- Finalise proposal for intake location and design for applications to be progressed (as necessary) - **31st March 2026**
