4. Details of our assessment

A site inspection was undertaken on Monday 10th November 2025. The following observations were made:

Waste Acceptance

It was noted that the site is temporarily receiving SDA (Small Domestic Appliance) waste only. This WEEE (Waste Electric and Electronic Equipment) is brought to site, bulked up and regularly removed. At the time of the inspection, it was suggested that there was approximately 40 tonnes of this waste type on site.

24-hour CCTV monitoring & Fire Detection systems are in operation in this area. The storage of this waste appeared to be compliant with conditions of the Environmental Permit.

Waste Storage & Site Infrastructure

Other waste types (ferrous/non-ferrous) wastes are segregated onsite and volumes of these wastes are being gradually reduced and regularly removed from site.

Site infrastructure is maintained to a high standard with impermeable site surfaces showing no signs of significant damage.

An inspection of the wharf area was undertaken and the river was high at the time of the inspection. The area of the river around the discharge point of the drainage system was free from all visible greases and oils. There was no visible sign of the discharge potentially polluting the river.

It is noted that during this period of change, where ownership of the site may change, the site remains manned and all risks from permitted activities are being effectively managed.

Compliance Assessment

At the time of the inspection, activities were assessed as being fully compliant with the Environmental Permit (EPR/UP3898FQ).
