## 4. Details of our assessment

This was a pre-arranged inspection as NRW officers were asked to attend site prior to the operator submitting their permit surrender application.

The site has not been operational for the past few months.

This inspection was arranged to check the condition of the site. The site had been cleared of all waste and associated equipment. The site stopped accepting waste last year and the tanks were removed from site in Q4 2024

The building is secure with lockable metal shutters.

The site appeared in good condition. There was a small amount of cardboard and several wooden pallets inside the building which would not be associated with the site waste activities.

Sustainability manager was present during the inspection and was made aware that documents supporting low risk surrender need to be submitted to NRW.

The site history has been reviewed and there have been no pollution incidents reported to NRW.
