### PERMIT INSPECTION

On Tuesday 4<sup>th</sup> of November 2025 NRW Officers Nicola ROSSITER and Cerys PHILLIPS attended the facility at 12.55 am for an unannounced routine inspection of permit number EPR/BB3294CB held by Welsh Water Organic Waste Ltd - Dwr Cymru. The weather was drizzly and overcast at the time of inspection. Officers ROSSITER and PHILLIPS were greeted by the Site Supervisor.

At the time of the inspection the site was operational, the site supervisor showed us around the section of the site relevant to the permit, this is a relatively small area within a much larger site run by Welsh Water. The site was free from litter and well maintained. The drains were clear and free flowing, no concerns with drainage, as shown in photo 1.

The site supervisor explained that maintenance regularly occurs on the site; the storage tank was scheduled to be deep cleaned the following week, shown in photo 2.

Both the bunded area the tankers unload in and the bunded area in which the storage tank is sited were in good condition at the time of the inspection, as shown in photo 3.

No offensive noises were witnessed by either Officer while on site. No concerns or actions were raised and Officers ROSSITER and PHILLIPS left site at 13.15 pm.
