## 4. Details of our assessment

On 22nd October 2025, Angharad Clark attended the site and met with the operator who showed her around.

### **The Site**

The site was in good condition with no security issues. There was a slight increase in processed scrap metal being stored due to SIMS, the ongoing recipient, going into liquidation.

### **Records**

Site records were readily available in the office. The permit and copies of both SR2011 No2 and SR2011 No3 were present and accessible. A copy of the Environment Management Plan was also available.

### **Fire**

A copy of the updated Fire Prevention and Management Plan was present and readily available in the office.

### **Other observations**

The operator's sister is in the process of completing WAMITAB training and will be taking over as the Technical Competent Manager upon certification.

No issues were observed at this time.
