4. Details of our assessment

A routine water resources inspection was carried out by Bethan Lewis from the Ceredigion Environment Team on 19 September 2025, who was met on site by Abid Mehmood, Head

of Operations at Ty Nant.

Source of Supply and Points of Abstraction

Water is abstracted from underground strata at Point A, Point B and Point C as outlined within Condition 2 of the Water Abstraction Licence and as shown in photographs 1, 2 and 3 below.

No issues were identified.

Purposes of Abstraction

Water abstracted from the borehole located at Point A is for use as a private water supply, while water abstracted from the boreholes located at Point B and Point C are for use in commercial water bottling.

No issues were identified.

Means of measurement of water abstracted

One meter is provided for each point of abstraction to measure quantities of water abstracted.

Meters for Point B and Point C were viewed at the time of the inspection. The meters are shown in photographs 4 and 5 below. The meters were located along the pipework leading from the boreholes.
