4. Details of our assessment

On 12 November 2025, Natural Resources Wales conducted an inspection of the package treatment plant operated by Eryri Accommodation Limited (Permit No. CG0376801). The permit was transferred from Wirral Borough Council to Eryri Accommodation Limited on 6

October 2025.

Officers were met on site by the new property owner. The package treatment plant is equipped with an alarm system and is installed below ground, with only the control box and power unit visible at the surface. No issues were identified during the inspection.
