Action 1: Confirm if site is FPF compliant. DCWW are the under the impression that the site is complaint. Raw data not required, just confirmation of compliance.

There is no FPF or overflow setting stipulated in permit BN0000701.

Action 2: Confirm if site is DWF compliant. Raw data not required, just confirmation of compliance

Dwr Cymru can confirm the site is DWF compliant with 229 days achieved and the Q90 well below the consent limit.

Action 3: During the site visit, DCWW confirmed that the storm overflow is on the list of unconsented assets. Please confirm progress in obtaining a permit for the storm discharge.

Porthgain is on the USO programme and due for classification by 31/01/26. Because there is no SO consent there is no FPF limit or weir setting at present for the site. This will be determined as part of the USO programme when the consent is applied for following classification.
