Inspection Report – Package Treatment Plant (CB3891CK), The Towers, Capel Curig

Conducted by: Natural Resources Wales

On 12 November 2025, Natural Resources Wales officers carried out an inspection of the package treatment plant (CB3891CK) at The Towers, Capel Curig.

Officers met with the site team and were escorted to the treatment plant, which was operating nominally. However, access to the plant was restricted due to overgrowth of brash.

Inspection of the outlet adjacent to the Afon Conwy showed no signs of fungal growth and was clear of debris.

As per Permit Condition 3.3.1, a permanent means of access for inspection and monitoring officers must be available at all times.

During discussions with the Centre Manager, it was noted that the registered company address currently listed as:

Seebeck House, 1 Seebeck Place, Milton Keynes, Buckinghamshire, United Kingdom, MK5 8FR

is incorrect. The correct registered address should be:

15 Eyston Way, Abingdon, Oxfordshire, United Kingdom, OX14 1TR.

As this is the official registered address, ALG Active Learning Centres must seek an administrative variation to ensure the correct address is reflected on the issued permit.

Ensure the treatment plant is accessible at all times.
