4. Details of our assessment

Notification of UWW Sample Exceedance – Llanfairfechan Waste Water Treatment Works (WWTW), CG0077001.

On Thursday, November 13, 2025, Natural Resources Wales (NRW) received a notification from Dŵr Cymru Welsh Water (DCWW) regarding an exceedance identified in their Urban Waste water directive (UWW) sample at Llanfairfechan Waste Water Treatment Works (WWTW), permit reference CG0077001.

The sample was collected on 04/11/2025 and recorded the following exceedance:

Biological Oxygen Demand (BOD): 27mg/l

Permit Limit: 25mg/l

This represents the first BOD exceedance at this site within the past 12 months.

It should be noted that this result is not classified as a permit failure, as it falls within the allowable number of exceedances based on the Look-up Table (LuT) and the site's sampling frequency.
