4. Details of our assessment

During site visit to this SPS, NRW officer asked what measures are in place to prevent the duty pump blocking and spinning dry, not sending flow, and the assist pump not taking over pumping duty. Referring to incident WIRS 2508467 and self-reporting WATPOL 317543172 for incident on 12 September 2025.

DCWW representative explained that there is a fail-safe 'SPIN alarm' but this was not functioning as designed at the time, so did not alert that no flows were being pumped forwards despite pump 1 operating. The alarm requires reconfiguring.

Please inform NRW what the cause of this issue was and when it was fixed.
