4. Details of our assessment

Routine site inspection of Llandegfedd Visitors Centre Wastewater Treatment Works carried out by Environment Officer Peter Jones. The weather was dry but overcast.

This is a small wastewater treatment works which consists of a bio disc, it's a covered unit which contains settlement chambers and a bio disc. The lids to each section of the system were locked and

secure. A visual inspection of the chambers was carried out and the works looked to operating as designed.

Daily checks have been completed and the onsite diary is up to date. The daily readings for pH ammonia and turbidity are all within the permit limits.

There was no visual impact on the Sor Brook at the final effluent discharge point.

There were no noncompliance with the permit noted and there are no follow up actions to be completed.
