4. Details of our assessment

A inspection was carried out at Gwynfe WWTW on 09/07/2025.

During the inspection it was noted that the tipping bucket was not operational, this resulted in flows not being spread over the filter bed and only flowing through one point on the bed.

The site operator told us that a tree branch had fallen on the bucket, causing the damage.

We drove to where the final effluent enters the Clydach and saw a plume of sewage fungus from the discharge pipe for 5/6 metres downstream.

In the permit for this site condition 1 states ;

1. The discharge shall consist only of treated sewage effluent from a population of 250 or less.

The effluent being discharged from the works is settled via the baffled tank at the inlet however it was not receiving treatment from the filter bed as all effluent was flowing through one small area of the bed. As such the effluent is being discharged without full treatment. We have recorded this as a category 3 breach.

In addition, leaking brickwork was seen on the filter bed, allowing some effluent to discharge to the ground and not via the permitted discharge point at SN 7266 2176. We have recorded this as a category 3 breach.

This report has been edited on 09/09/2025 to extend the deadline given for the required repairs to be made to 31/10/2025
