4. Details of our assessment**Wepa UK Limited****EPR-3738NG**

This compliance assessment form captures the light touch review of the Wepa installation Climate Change Adaptation Risk Assessment (CCARA). The review is considered a light touch review, only to assess if the CCARA is up to date and includes the expected information, it is not a technical review.

Overall Summary

The CCARA provides a site-specific review and identifies relevant climate-related threats. Impacts at the site and operational level have been well considered. Mitigation measures have been proposed to limit or manage the risks identified. However, there are several areas where improvements would ensure a comprehensive and robust approach to climate risk management.

Strengths

- The assessment is site-specific, focusing on the Bridgend facility operations and infrastructure.
- It identifies five key threats: flooding/extreme rain, drought, extreme temperatures (high and low), and high winds.
- Proposed actions to manage identified risks are realistic and relevant.
- There is a commitment to annual review, supporting continuous improvement.

Areas for Improvement**1. Sector-Level Risks**

- The assessment does not consider broader sector impacts or risks beyond the physical site.

Recommendation: Include sector-specific vulnerabilities and interdependencies.

2. Timeframe of Risks

- Risks are not categorized into short, medium, and long-term horizons.

Recommendation: Structure the assessment to reflect different timeframes for better planning.

3. Climate Projections and Scenarios

- Current and future scenarios are not clearly differentiated. Actual projected data, in terms of potential increases in temperatures etc have not been included in the assessment.

Recommendation: Reference authoritative climate projections and outline how risks evolve over time.

4. Exposure and Prioritization

- While on-site operations and ecosystems are addressed, supply chain impacts are missing, and no prioritization of risks is evident.

Recommendation: Include supply chain considerations and prioritize risks based on severity and likelihood.

5. Key Performance Indicators (KPIs)

- No KPIs are included to measure progress or effectiveness of actions.

Recommendation: Develop KPIs to track resilience improvements and risk mitigation.
