4. Details of our assessment

Veolia Energy and Utility Services UK Plc

This compliance assessment form captures the light touch review of the Veolia installation Climate Change Adaptation Risk Assessment (CCARA). The review is considered a light touch review, only to assess if the CCRA is up to date and includes the expected information, it is not a technical review.

Strengths

1. Site-Specific Assessment: The CCRA is tailored to the Pontypridd site.
2. Climate Projections: Various projections have been referenced, including temperature, sea-level rise, river flow, and storm events.
3. Risk Management Actions: Actions to mitigate identified risks are included and appear relevant, reflecting the low-risk nature of the site.

Areas for Improvement

1. Sector-Level Risks: Sector-specific risks are not considered, though this may be due to the site's designation as a DAA and limited applicable considerations.
2. Timeframe Segregation: While some timeframes are mentioned, short-, medium-, and long-term risks are not clearly defined.
3. Exposure and Prioritization: On-site operations and ecosystems are addressed, but supply chain impacts are not considered, and prioritization of risks is absent.
4. Key Performance Indicators (KPIs): No KPIs are included. Adding measurable indicators would support monitoring and accountability.
5. Update Plan: There is no reference to regular updates of the assessment. While site closure is planned, this omission is noted.

Recommendations

- Clearly define short-, medium-, and long-term risk categories.
- Include prioritization of risks for clarity.
- Add KPIs to track progress and effectiveness of mitigation actions.
- If site closure timelines change, incorporate a formal review schedule for continuous

improvement.

It is appreciated that the Veolia site is no longer operational and a permit surrender is imminent. As such, no further actions will be issued in relation the CCA RA as there is little benefit to be gained from any review.
