**4. Details of our assessment****Castle Waste Services Limited****EPR/LP3439HM**

This compliance assessment form captures the light touch review of the Castle Waste Services installation Climate Change Adaptation Risk Assessment (CCARA). The review is considered a light touch review, only to assess if the CCRA is up to date and includes the expected information, it is not a technical review.

**Strengths**

1. **Site-Specific Assessment:** The CCRA is tailored to the Cardiff site, covering specific operations and infrastructure.
2. **Sector-Relevant Risks:** Climate hazards and risks relevant to the waste sector have been considered.
3. **Future Projections:** The assessment includes future climate projections (temperature, rainfall, storm occurrence, and sea level rise), which are well-defined.
4. **Exposure and Prioritization:** Risks to infrastructure, supply chains, assets, and operations are addressed.
5. **Risk Management Actions:** Proposed actions for managing high risks appear realistic and relevant.

**Areas for Improvement**

1. **Timeframe Segregation:** Risks are not categorized into short, medium, and long-term. While worst-case projections are used, explicit segregation would strengthen the assessment.
2. **Ecosystem Impact:** The impact on ecosystems could be better defined.
3. **Key Performance Indicators (KPIs):** KPIs are not explicitly included. Adding measurable indicators would support monitoring and accountability.
4. **Update Plan:** There is no clear plan for regular updates based on new data or emerging climate trends. A commitment to periodic review should be incorporated.

**Recommendations**

- Include short-, medium-, and long-term risk categorization for clarity.
- Define ecosystem impacts more comprehensively.
- Add KPIs to track progress and effectiveness of mitigation actions.
- Establish a formal review schedule to ensure continuous improvement.
