3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

During a routine compliance assessment check that we have carried out on 04/04/2025 it was noted that the EDM operational time for this asset was less than the minimum of 90%. The operational time provided in the 2024 EDM Annual return for BW1402001 Old NCB Yard CSO, Penybanc was 5.83%. Condition 3.1.1 states that “The operator shall, unless otherwise agreed in writing by Natural Resources Wales, undertake the monitoring specified in the following tables in schedule 3 to this permit: (a) point source emissions specified in table S3.1 and table S3.4”

Guidance for scoring the non-operational time and historical data submitted suggests that this may have had a minor environmental effect and has therefore been categorised as a category 3 non-compliance.

The data submitted was initially made within the required deadline as specified by the permit (28 February 2025). The data was then resubmitted after the deadline. The resubmission was made because the original data was erroneous. This resulted in condition 4.2.2 (b) being breached as the correct data was not submitted within the deadline. The permit holder had been operating the asset whilst using erroneous data relating to discharges. This had the potential to result in discharges being made without a system which minimised pollution. This has the potential to lead to significant impacts on the environment and is a breach of permit condition 1.1.1.
