### 4. Details of our assessment

On 27 October 2025 we received a WIRS report stating that the outfall from Bishopston STW was damaged and had a roughly 10cm long hole in it, in the intertidal zone. It was reported to not be discharging onto the beach at the time but had the potential to discharge while submerged at higher tides. DCWW confirmed this with a site inspection.

A repair was initially planned for 3 November but was postponed.

A further update received on 12 November reported that the hole in the pipe was discharging final effluent onto the beach at lower tide, while the hole was not submerged. Photographs were received and forwarded on to DCWW.

This discharge is occurring in breach of Permit Condition 2.2.1 which specifies that the discharge activities shall take place at the discharge points marked on the site plans in schedule 7 of this permit, and as listed in table S3.2; notably below mean low water.

This breaches is in contravention of Regulation 38 (2) of the Environmental Permitting (England and Wales) Regulations 2016 which states that it is an offence for a person to fail to comply with or to contravene an environmental permit condition.

Action needed to come back into compliance: Submit a plan for the repair, including timescales, to Swansea Environment Team.
