4. Details of our assessment

This report details the site visit made on the 4th November 2025 to Wastesavers located at Esperanto Way, Newport, NP19 0RD under permit number, EPR- AB3191ZE. Natural Resources Wales (NRW) Waste Regulation Officers Cerys PHILLIPS, and Nicola ROSSITER attended the Wastesavers facility for an unannounced site inspection at 11:00am where they met with Ian SYMS (Head of Operations). The weather was rainy at the time of inspection.

SITE OBSERVATIONS

NRW officers were escorted around the yard to initial sorting area for plastics, then taken inside to the drop off area for the household waste bin lorries.

NRW officers were also shown the sorting equipment used to separate the Plastics and Metals waste stream. Aluminium cans, steel cans, and plastics are extracted from the conveyor based on their weight.

General housekeeping on site was good with minimal litter and no concerns of it leaving the permit boundary. The staff operate a clean as you go method to keep litter and debris on the site to a minimum.

The sealed drainage systems appeared to be in good working condition at the time of the inspection, with only a small amount of standing water observed on site, as to be expected whilst raining.

Image 1 shows food waste is stored in large tank in a building, as required by table S1.1 within the permit.

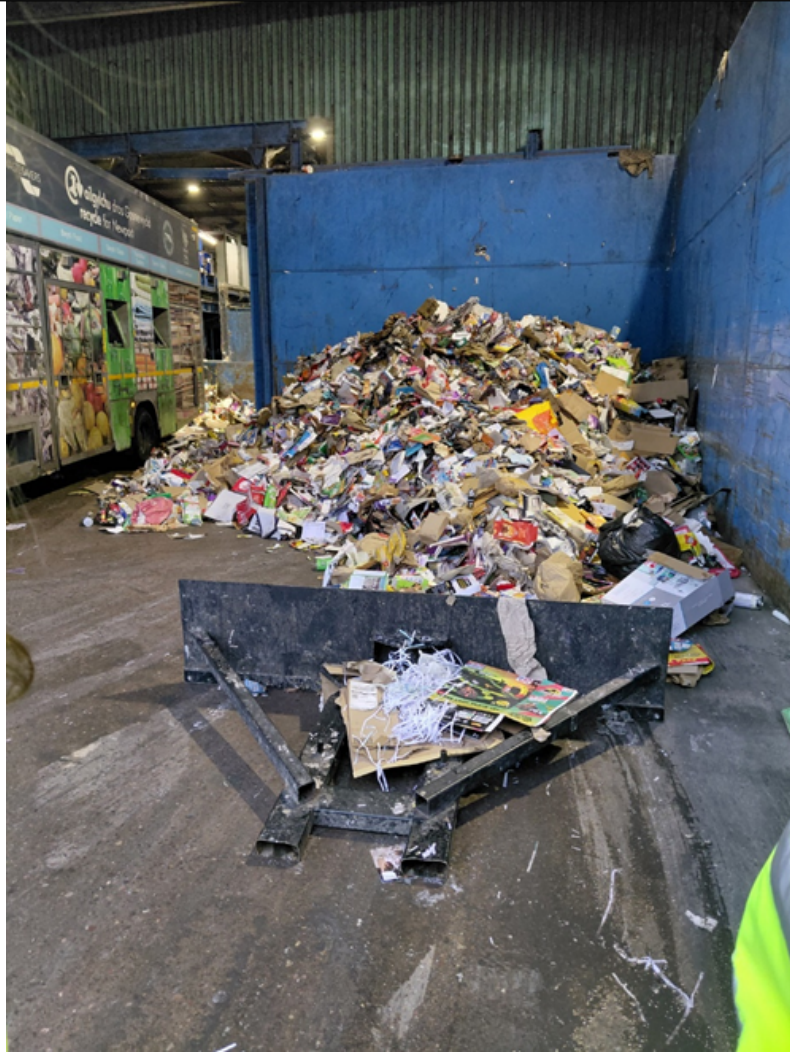
