4. Details of our assessment

This Compliance Assessment Report (CAR) details the comments of Natural Resources Wales (NRW) for the assessment of the submitted climate change risk assessment by Viscose Closures Limited (the operator), in relation to the Cellulose Extraction Plant in Swansea, SA6 8QN for activities undertaken under the environmental permit EPR-VP3635SY.

We have carried out a basic review of your risk assessment and identified areas that are missing or inadequate.

Compliance breach

A suitable management system can minimise the environmental risk from permitted activities, not being able to operate within the conditions set out in your permit could have environmental consequences with a range of reasonably foreseeable impacts.

Therefore an inadequate climate change risk assessment has been recorded as a contravention of permit condition 1.1.1(a) and has been assigned a non-compliance score of a category 3 (recorded against sub criteria IR1A Installations – Management – General Management).

Action - Update your climate change risk assessment to ensure it includes the following information and submit to Natural Resources Wales by 01.03.2026:

- **Ensure the risk assessment is site and sector specific.**
- **Uses the most up to date future climate projections to predict current and future climate risks (ensuring climate hazards and risks relevant to the sector have been considered and short, medium and long term risks have been included).**
- **Identifies and priorities all elements that are exposed to risk (i.e assets, infrastructure, operations, supply chains, ecosystems and people).**
- **Includes actions to manage the high risks.**
- **Identifies key performance indicators to monitor and measure environmental performance.**
