2025 Q3 Monitoring Reports

Cabot submitted forms A1, A3 and W1 for Q3 2025 on 28th October 2025.

Emissions to air of carbon monoxide, chlorine, chloromethanes and hydrogen chloride from emission point A1 are all compliant with the permit limits.

Emissions to water at emissions points W1, W2 and W3 are all compliant with the permit limits.
