4. Details of our assessment

On Thursday 20th November 2025, Waste Regulation Officer, Joe Weatherley visited the site after receiving a report that the netting atop the boundary wall of the site was damaged. The reporter stated that during a visit to an adjacent business, the staff there pointed out the damage and the presence of items of litter on the ground. Upon arrival at site, the officer was greeted by the site manager who was informed of the report to NRW. The site manager then accompanied the officer around the site to view the netting. In several places the netting was damaged or loose from the supporting frame. Items of litter had built up inside the netting at some points along the perimeter and were starting to emerge from the bottom of the netting. The officer pointed these issues out to the site manager. The officer also pointed out the presence of litter items on the ground on the adjacent business property.

ACTION: Effect repairs to litter netting. Monitor litter netting and if necessary remove trapped litter, to prevent overloading and potential escape of litter from the site.

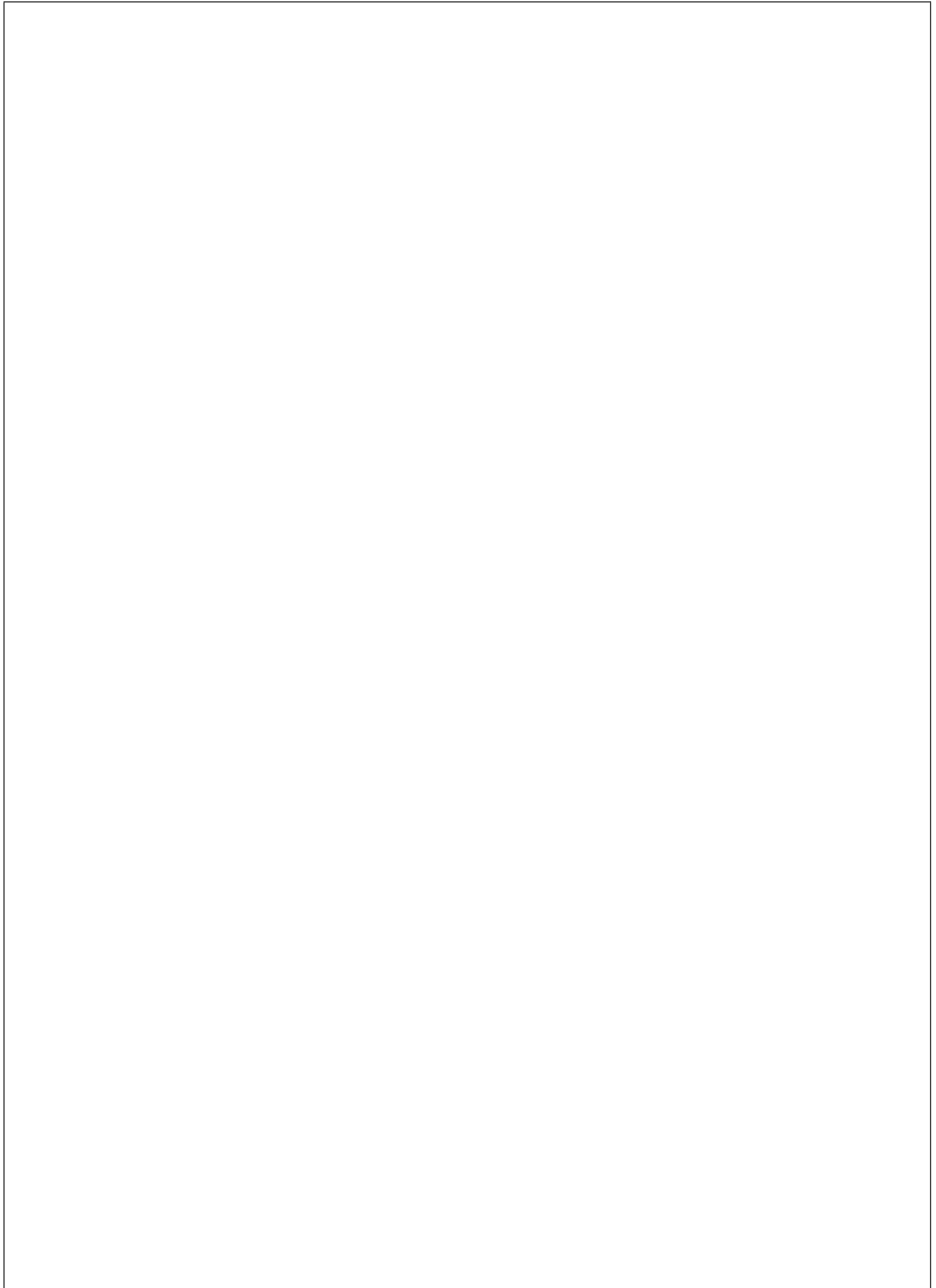

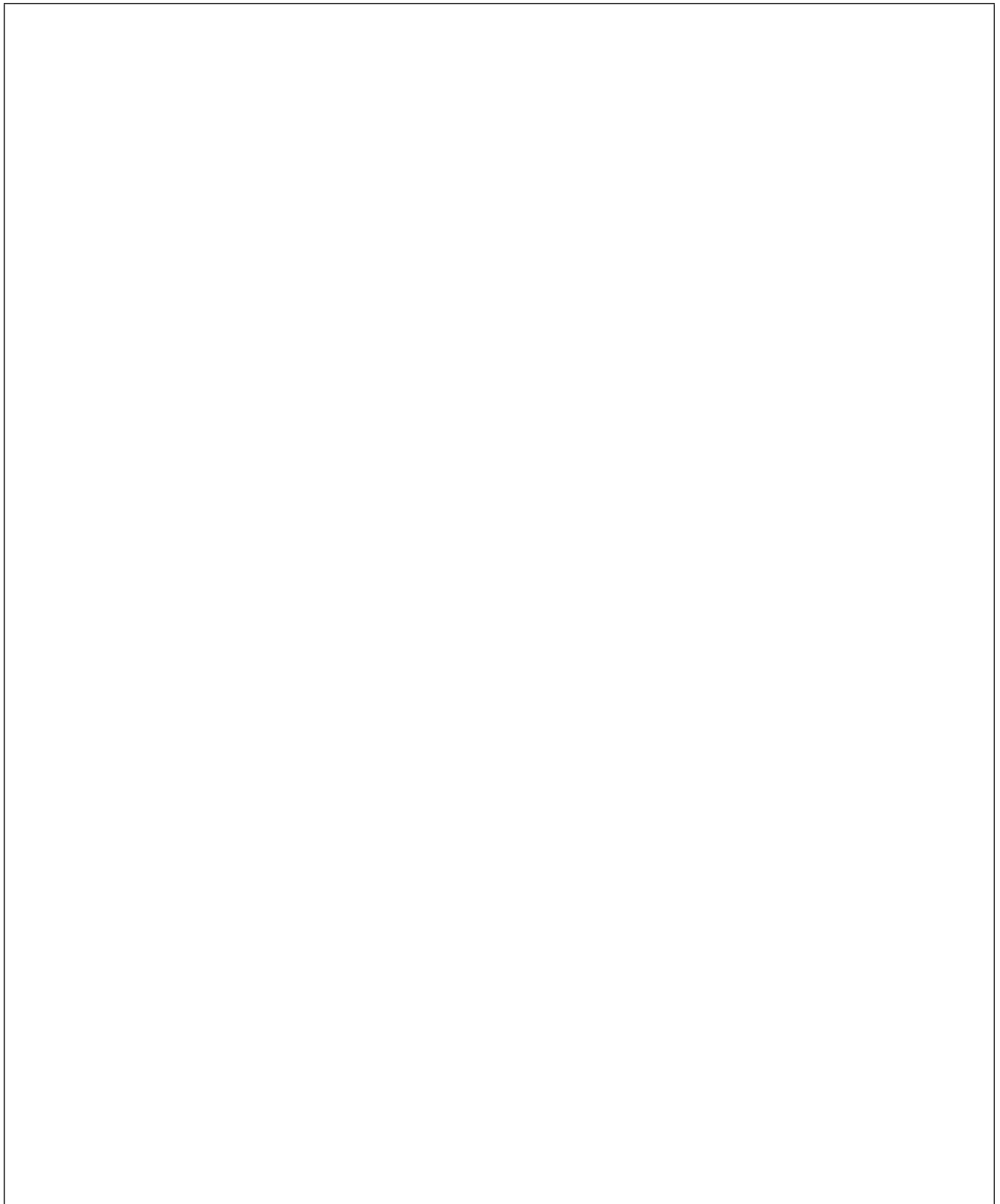
