## 4. Details of our assessment

### AMENDED CAR FORM

The site inspection formed part of NRW's Permit Compliance Workplan. NRW staff and three Dwr Cymru Cyf. staff (the Operator) were in attendance. The purpose of the site inspection was to visually check operator's site management compliance against the permit.

The Gwalchmai WwTW was well organised and tidy.

**Non-compliance:** A substantial pool of water on the site track observed. This was present despite dry weather on the day and several days prior to the inspection. The Operator did not know the reason for this accumulation of surface water. No evidence could be found that it came from the sewage treatment process on site, and no smell nor sewage fungus visible in this area. The Operator are advised to investigate the reason for the pool of water including analysing the water from the pool during dry weather. Analysis to include chloride, phosphate and ammonia analysis. Please report findings to NRW.

*Note: The target date has been extended to the 31st March 2026 following discussion with Dwr Cymru Cyf. to allow more opportunity to get spell of dry weather to undertake the analysis. If, however, the winter/early spring is too wet to undertake the analysis, Dwr Cymru Cyf. should contact NRW **before the 31st March 2026** to ask and agree a revised target date extension.*
