### 4. Details of our assessment

Remote inspection of the site and the records carried out over video call due to Avian Influenza restrictions by operator. All parts of the permit inspected.  
The sign was not on the gate during the inspection. It was still on the old shed that had been moved away from the gate and out of sight. Following the inspection, it was confirmed as being on the gate later that day.  
The Health, Environment and Safety review was one month past the due date at the time of the inspection. Please ensure that this is updated by 18th December 2025.  
Concrete bitumen repairs undertaken and tidy site.
