4. Details of our assessment

Thankyou for taking the time to show me around the poultry unit, and to check through your paperwork. You confirmed during the visit that you prefer all communication from NRW to be in English.

At the time of the visit you had two signs at the entrance to your unit, with differing permit numbers, and the incorrect emergency number for NRW. This was raised as an issue in CAR_NRW0032120 in 2017. You have already confirmed that the sign has been updated and is now compliant.

You last submitted a 4 year review in January 2022 so this will be due again in January 2026. Please submit it to NRW as soon as possible after the end of 2025.

There are signs that some of the concrete around the yard is starting to crack giving potential for dirty water to leak through the cracks and contaminate groundwater. Your site is within a source protection zone so it is important to ensure that no pollution can escape from the site via this route.

Action: Keep an eye on this during your regular inspections, and consider repairs to the concrete is required.
