4. Details of our assessment

Overview

This Compliance Assessment Report (CAR) has been prepared following an inspection of the permitted site.

The purpose of the inspection was to:

- Review operator records relating to technical competence.
- Meet with the operator to discuss permit requirements.
- Introduce the designated lead regulatory officer.

Records

Condition 1.1.1 of the environmental permit requires the operator to:

(a) Manage and operate activities in accordance with a written management system that identifies and minimises pollution risks, including those arising from operations, maintenance, accidents, incidents, non-conformances, and complaints.

(b) Ensure sufficient competent personnel and resources are in place.

Condition 1.1.2 requires records demonstrating compliance with Condition 1.1.1 to be maintained.

The operator provided records of their compliance with an approved competence scheme. While a full assessment of technical operator competence was not undertaken, records of staff qualifications (CIWM certificates) were observed. This represents compliance with condition 1.1.2 in relation to maintaining records of staff competence schemes, only.

Permit Requirements

Improvement Condition 1 (refer to page 18 of the environmental permit) requires the operator to conduct a full noise monitoring survey and assessment in accordance with BS4142:2014 + A1:2019 upon commencement and operation of the Ulster U150 Shredder and associated conveyor systems. Additional actions may be required depending on the survey outcome.

The operator submitted their response within the specified timeframe. Natural Resources Wales will review the submission and confirm compliance with the improvements outlined in Schedule 1, Table S1.3 in a separate CAR.

Beyond queries relating to the Pollutant Release and Transfer Register, the operator raised no further questions regarding permit requirements.

Introduction to Regulatory Officer and Site

The accompanying regulatory officer (named above) will now act as the lead regulatory officer for this site.

A general overview of site operations was provided; however, no compliance assessment was undertaken during this introduction/overview.
