On Friday 12th September 2025 at 1030h, the Permitted location relating to EPR-ZP3535MW was inspected by NRW officers I JAMES and N GRIFFITHS.

The Permit was confirmed as non-operational, although no internal inspection was possible due to the fact there was no presence on site, and the general poor condition of the roof would have rendered any inspection unsafe for entry.
