4. Details of our assessment

Senior officer Elysia Lovelock and Enforcement Apprentice Daniel Hopkin, attended Seawall Waste Transfer Station, Unit 82 Seawall Road, Cardiff, CF24 5TH on Friday 20th June 2025 to conduct an initial inspection of the recently permitted facility, in relation to environmental permit EPR/DB3395CG, issued 6th January 2025.

The Operator, Plan B Management Solutions Limited, hold a standard rules permit, with SR2008 No03 being conditions of the permit, for a household, commercial and industrial waste transfer station with treatment. Treatment consisting only of manual sorting, separation, screening, baling, shredding, crushing or compaction of waste into different components for disposal, (no more than 50 tonnes per day) or recovery. With no more than a total of 50 tonnes of intact and shredded waste vehicle tyres (waste codes 16 01 03 and 19 12 04) shall be stored at the site. With a total quantity of waste accepted at the site to be less than 75,000 tonnes a year.

The Environmental Permitting Regulations 2016 place a duty on regulators to undertake appropriate periodic inspections of regulated facilities (regulation 34(2)).

On our arrival, at approximately 1030am, officers observed that the premises are still under construction and therefore, not yet operational.

Whilst it is normally the case that we conduct unannounced inspections without prior notice to verify compliance, as an initial inspection is still required, once the facility is up and running, please get in touch and we can arrange an initial visit to run through the information we provide at an initial inspection.
