#### 4. Details of our assessment

This Compliance Assessment Report (CAR) summarises the findings of offsite odour monitoring, in response to received WIRS reports, A routine unannounced site inspection at Hafod Landfill was undertaken immediately after the odour monitoring. The off site odour monitoring was then repeated following the site inspection.

The weather conditions preceding the site inspection included very heavy rain; at the time of the inspection the weather was dry and cold (approx. 7 degrees Celsius), with a slight south-easterly breeze.

NRW officers completed offsite odour monitoring both before and following the site inspection, at the following locations:

- New Hall Road- no odours
- Shellbrook Drive Ruabon- no odours
- Bedwell Drive – no odours
- East Avenue – no odours
- B5605 – no odours
- Vauxhall Industrial Estate- distinct burning odour (3/6) and distinct undefined chemical odour (3/6)
- Ruabon Road near Co-op - no odour
- Heol Hafod, Heol Kenyon & Heol Orsaf - no odour
- Bryn Hyfryd - no odour
- Y Gesail - no odour
- Tan y Clawdd, Y Fron, Gwalia, Worsley Avenue and Melyd Avenue – no odours
- Ponciau - no odour
- Top (west) Bangor Road- very faint waste odour (1/6)
- Bangor Road at Hafod Landfill entrance- faint /distinct waste odour (2-3/6)
- A483 - no odour

Following the first round of odour monitoring the NRW Officers met with the Regional Manager on site. The access road was clean at the time of arrival and a covered waste vehicle was on the site road waiting to be received at the weighbridge.

Both gas engines were running at the time of the inspection and the flare was off.

The road sweeper was noted to be active on the access road at the end of the site inspection.
