4. Details of our assessment

On Thursday 21st November 2025 Natural Resources Wales officers attended site. This was a routine site inspection for permit ref EPR DB3736AT which was carried out by Waste Regulation Officer Ian Thomas.

On arrival at site, I Thomas met with Robert Morris, site operative and maintenance manager, Robert accompanied I Thomas throughout the inspection.

At the time of the inspection the facility was not operational due to a power failure. Robert explained that the site has been running well and they had looked at ways to expand the operation.

The food waste storage building was locked due to the power failure. The system is working well without the requirement of any additions, the materials from the bottom of the digester can also be removed and used as a natural fertiliser.

The site has a storage of poultry litter which is fed into the digester, it was noted that the level of the storage is slightly above the concrete blocks. **Action – please ensure the storage level is reduced so that materials are fully contained.**

The site has 2 CHP engines located inside a separate building, on the last inspection a

number of oil drums were stored inside the building and close to the CHP engines. These have been removed and now have a separate covered storage area. There was one drum inside building, please ensure this is relocated to the storage area.

On returning to the office, a check was carried out on the site administration. Waste transfer notes were checked, a copy of the permit was available, and a site diary is being used to record any incidents. All looked to be in order.
