4. Details of our assessment

Environment Officer Peter Jones attended the site on 17 December 2025 and met with the site manager.

To remind the operator, following each assessment Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the audit. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions. This can affect your site banding and annual subsistence fees; scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the people/property/environment
- 2 - Significant impact or effect on the environment/people/property
- 3 - Minor impact or effect on the environment/people/property
- 4 - A non-compliance which has no potential environmental effect

Site Report

The inspection involved a visual examination of the site infrastructure and drainage and a review of documents required under the permit conditions. Overall the site infrastructure was found to be in good condition with no issues identified with the concrete surface or the surface water drainage system. The site was clean and tidy and there were no reports of noise or odour complaints.

Following the site inspection, the officer proceeded to the site office to inspect documents required under the permit conditions, these were all in order and available for inspection.

Waste disposal

Carcases are currently removed by Celtic Baits and waste transfer notes are all in order.

When required, skips are supplied by Thomas Waste Ltd.

Other wastes are removed to GD Environmental Ltd by the site owner who holds a waste carriers licence, registration number CBDU578612.

Manure

Manure is removed immediately from site when the sheds are emptied of stock and transferred to Glan Orchran Dairy Farm (CPH 60/113/0009). There is no requirement on site for manure storage facilities.

There were no issues found with the management plans or incident procedures all of which have been reviewed recently
