4. Details of our assessment

In the document FPF Path to Compliance for NRW reported sites, with reference to Dale STW. In the column headed, Route to Compliance , the text below is stated:

The MBR membrane cassettes were subsequently replaced during October 2022. Post replacement performance improved considerably, and the site was compliant for a period but failed to demonstrate annual compliance for 2023 due to ongoing salinity issues

impacting the MBR performance. The site is currently compliant for ~85% of spill events year to date. An AMP8 scheme is currently planned to pump all flows to an upgraded treatment works in nearby Marloes. This will remove the ongoing resilience risk associated with the membranes treatment in a coastal catchment with high salinity ingress potential.

Is this the current situation or is an update available? We are aware that progress has been made regarding removing saline intrusion.

Update received from DCWW 09/12/2025

We can confirm the statement detailed in the CAR form is the latest update on the AMP8 scheme, Dale/Marloes is currently with our ECS partners undergoing design/options engineering. In regards to the lining works to remove saline intrusion, this has been delayed due to the long delivery lead time of the liner as it is not a standard size/type due to needing sailing protection. A chase has been sent today on the supplier of the liner for more updates on expected delivery.
