4. Details of our assessment

In the document FPF Path to Compliance for NRW reported sites, with reference to Dale STW. In the column headed, Route to Compliance , the text below is stated:

Site reported as non-compliant for 2023. Investigaiton confirmed blockages at the inlet were the causes of the site failure. The site is now closely monitored by the operational team with increased desilting visits. Site is expected to be compliant for 2024. A new WwTW is planned for AMP8 to address ongoing DWF non-compliance as a result of catchment tourism and will improve blockage resilience.

Is it now confirmed that the site is compliant for FPF as referred to above. Also, is the proposal to upgrade in AMP 8 to address ongoing DWF non compliance and what is the timescale for this?

The statement detailed in the CAR form is correct. We are still planning AMP8 investment to address the DWF non-compliance here. Due to the complexity around aligning this with Dale solution and Storm Overflow IMP1 scheme at Marloes we are not able to give definitive timescale until the solution & design details has been agreed.
