4. Details of our assessment

Routine inspection of Asset. The weather conditions were showers at the time of the inspection with heavy rain in the days prior.

The site is a Wastewater Treatment Works that processes sewage effluent. The permit (BH0060601) for the site is for the discharge of secondary treated sewage effluent to the Afon Teifi and storm sewage to the Nant Bargod .

Officers were taken through the works from inlet, through the treatment system, and the final effluent sampling station. Officers were unable to check the discharge points to the Afon Teifi and Nant Bargod due to access and health and safety issues as the river levels were high at the time of the inspection. The discharge seen in the final effluent sample point appeared clear.

The Process

Effluent enters the site at the inlet where all flows pass through a screw press screen. The effluent then enters into 4 Primary tanks. There is a storm overflow on the inlet where flows spill to the storm tanks. The storm overflow was operating at the time of the inspection. All storm sewage is pumped with the final effluent to the discharge point in the Afon Teifi.

The effluent then gets treated by 4 filter beds. The filter beds appeared to be in good working order with the arms moving freely and there was no excessive growth of vegetation or pooling. The effluent then enters into 2 final settlement tanks before then being pumped to the discharge point into the Afon Teifi.

There is also an emergency discharge point to the Nant Bargod, this is only used in the case of emergency or if the pumps in the final pumping station fail.

Permit breach

Condition 2.1 The only activity authorised by the permit is the activity specified in schedule 1 table S1.1; the discharge of secondary treated sewage effluent via the Final Effluent Discharge Point

There was sewage leaking out of cracks in the brickwork/ concrete of the inlet balance chamber, the feed chamber of the larger primary tank and the feed chamber of the larger biofilter bed. These leaks led to sewage pooling on the ground. It was discussed at the time of the inspection that the source of this leak needs investigation and repairing to prevent further discharges to the ground.
