4. Details of our assessment

A routine site inspection was undertaken on Friday 5th December 2025.

Parts of the permitted activity assessed were General Management, Site (infrastructure) and Records (management systems).

On Friday 5th December 2025, the following observations were made:

General Management & Infrastructure

At the time of the inspection, the site was busy with multiple skip exchanges being carried out. The site temporarily closed to members of the public as skips were removed and replaced.

An inspection of the boundary was undertaken and only very minor amounts of litter were at the boundary. Areas behind skips were kept clear and infrastructure (specifically fencing) is well maintained.

Please ensure regular checks of the site boundary are conducted and any litter that has escaped site is removed.

There was minor amounts of dirt/debris around drainage channels but there was no ponding or pooling of sit surface waters.

Waste Storage

Waste was clearly sorted and segregated. Staff on site, when asked, had a thorough understanding of the process for quarantining non-list wastes and other incident management practices were discussed.

Records

Copies of the Environmental Permit and Environment Management were made available on request. Officers discussed aspects of the permitted operations, incident management and staff had a good understanding of their responsibilities in relation to permit compliance.

Operations were assessed as being fully compliant with the Environmental Permit. No non-compliances with the permit were recorded.
