Following a review of recent permit failures within the team, an error was picked up in the above CAR form. Previously we told you that the result was not a breach due to it being within 10% of the permit limits, however this was based on erroneous information and no such dispensation exists. Therefore the above sample will be counted as a C3 Non-compliance.

As a result of reviewing this sample, we are of the opinion that your sample point is inadequate and may be contributing to the sample failures due to solids being disturbed during the sampling process.
