4. Details of our assessment

Following Storm Claudia DCWW, requested a site meeting to review the damage caused to the WWTW.

DCWW staff advised the site had been flooded when the water level on the Candwr brook rose. Following the flood, one of the four settlement tanks on site had been damaged to the point it was no longer operable. As a result of the storm damage the settlement capacity at the site has been reduced by 25%.

DCWW staff advised the remaining three settlement tanks are able to cope with the flows but are concerned should there be an issue with one of the remaining settlement tanks. Which could then

have an impact on the quality of the final effluent discharge.

Options to provide alternative settlement capacity were discussed but nothing has yet been confirmed.

This CAR has been issued to record the damage to the settlement tank following the storm event.

A meeting to discuss potential solutions is to be held at the Llanfoist WWTW on the 19 Dec 2025.
