4. Details of our assessment

Perimeter Odour Inspection - Llanddulas Compost Site

A compost site perimeter odour inspection was conducted at 10:30hrs on the 12th of December 2025 for evidence of off-site odour from the compost facility.

The atmospheric conditions were calm and cool, which are the conditions in which odour issues would be most prevalent and detectable in these areas.

No trace of odour was detected in any of the areas assessed on the day.

Further unannounced perimeter odour inspections may be undertaken by NRW over the coming months to ensure continuing compliance.
