This compliance report is the result of the site inspection of Argae Lane CSO (AN0392801) carried out by NRW officers Alex Grainger and Hannah Jenkins on 27/11/2025.

Arrived at site at 09:10am with DCWW. Inspected the screens which looked to be clear with no debris / rag present.



This asset has no recorded spills in the past according to DCWW storm overflow map.

Inspected the outfall of this asset which also looked to be clear with no signs of debris visible.



NRW have decided that this site is compliant with its permit and no further action is required.
