This site inspection was carried out on Monday 16 September 2019 by Natural Resources Wales officer Ross Briscoe (Senior Officer Waste & Industry Regulation).

Present was Lee Jones of Worldcare Recycling Limited.

Prior to the inspection being carried out on this permitted area which is operated by Worldcare Recycling Limited, the regulating officer had inspected the neighbouring site which is operated by World Care (Wales) Limited – the sites are adjoining.

The visit consisted of a brief inspection of the permitted area only, on this occasion no site documentation relating to this permit was reviewed.

Weather conditions throughout the inspection were dry and sunny.

No waste activities (apart from waste storage) were taking place on the site whilst the regulating officer was present.

Only permitted wastes were observed within the permitted area.

Large stockpiles of both waste and possessed material were stored on site. The regulating officer was informed that these stockpiles would reduce in quantity over the coming weeks due to upcoming contracts.

The highway outside the site was also clear of mud/debris and appeared to have been recently swept by cleaning equipment.
